How to Enter

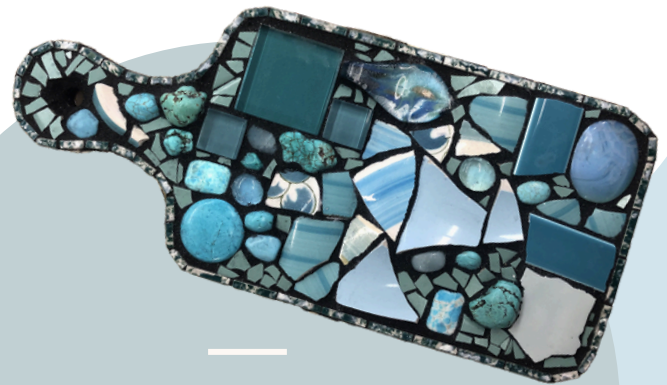

Agreement in Principle

_____ (Artist) and St. Madeleine Sophie's Center (SMSC) representing the Alley Cat Art Walk committee, agree to paint a cutting board that will be exhibited, marketed, and for sale at the Alley Cat Art Walk on Friday, September 13, 2024. Artist will receive a free cutting board with the understanding that the finished cutting board is property of the Alley Cat Art Walk committee. Paint & Pallet is a community service project, and the sale of cutting boards benefits the Historic Downtown El Cajon District by contributing funds to paint a new mural.

Promotional Usage

Submitted art may be used for promotional purposes by Alley Cat Art Walk committee, Sophie's Gallery, and SMSC including on postcards, websites, Facebook accounts, and other such promotional uses for which the Artist expects no payment or royalties.

Payment, Pricing and Sales Tax

Sophie's Gallery as a representative of the Alley Cat Art Walk committee will handle all sales and taxes of cutting boards during and after the Alley Cat Art Walk event. SMSC and Artist considers the Paint & Pallet artwork as a community service project. SMSC and Artist understands that finished artwork is owned by Alley Cat, and Artist waives any payment. 100% of the sale price, exclusive of sales tax, will go towards painting a new mural.

Show Set-up and Take Down

Artist agrees to deliver finished pallet on or before September 2, 2024.

Show Terms

Artwork should be family friendly. The Alley Cat Art Walk Committee has the right to not display finished artwork, if it is deemed inappropriate.
